b. Tourism Pilot Community Grant (Goal List #5) – Jordan
There is a grant through Senta Bill 540 that was newly e

There is a grant through Senta Bill 540 that was newly established by the Legislature this year that sets aside a significant portion of funding for communities that meet the following characteristics, 1. Under touristed, 2. Less than 30,0000 population, 3. You have to be a community that is primed and ready for tourism increase. What you get over the course of 5 years is 2.75 Million Dollars. It's divided up different ways every year. How its starts are, the 1st and 2nd year is you do a lot of planning (Steering Committee, hire experts, survey outreach, what does the community want), Year 3: Build Capital Infrastructure, promotional materials, marketing, signage. 4th & 5th year follow up of the last couple of years.

We need a Steering Committee that will meet regularly, set priorities, determine the level of expertise needed, and guide the process over the course of 5 years.

The most important thing with this grant is an active and enthusiastic Steering Committee of 8-10 members.

In order to strengthen our application, a MOU (Memorandum of Understanding) or a Resolution with the Chamber and County stating that we all three agree to spearhead this project. Seeking recommendation from this committee to write the MOU or a Resolution stating the County supports this, and they are actively involved.

Member Hayes motioned to recommend City Staff to write and MOU or a Resolution to support the grant discussed. Chairman Henderson seconded the motion. 2 Ayes, 0 Nos, 1 Absent. Motion passed.
