4. New Business:

a. Successful Deer Lodge update--Randy Carpenter

Randy Carpenter from Future West discussed updates on Successful Deer Lodge. This project is fully funded through an EDA Grant (by Headwaters RC&D) and Treasure State Fund Grant. Randy continues to see the two main needs of Deer Lodge as a) Housing and b) Revitalizing Downtown. Housing supply (no lots, no employees, high cost of materials) v. demand (rentals v.

owners needed, TIF funding options, CDBG funding options, Rural Development options, clearing/developing land options) was discussed. Randy is working with Wendy Sullivan from SouthWest....? to do a Community Profile. End goals will be to establish a Regional housing committee, have interviews completed by the week of March 22, have an action plan list completed by June, and have a concrete action plan completed by the end of summer. Committee needs to send interview names to Randy after he lets us know who he has already interviewed.

b. Chamber Report--Bridgett Herrick, President

Bridgett Herrick and Julie Schroder discussed the Chamber of Commerce upcoming events. They will provide a two-month calendar online (link sent to Cyndi for city website) and emailed/printed by request. They have been cleared for all outdoor activities and will be having a Color Run in June.

Committee needs are to help City contribute to "Welcome" basket items to new businesses in town (two this month).

c. Discover Deer Lodge Report--Amber Brown

Amber Brown discussed Discover Deer Lodge upcoming events. They have a Basketball Calcutta on March 17 goal is to make this an annual event. Cooking on the Clark Fork is cancelled. Stick & Bays will be the end of July, Location still pending. They are focused on the renovation of 502 Main St. and have applied for a \$50,000 grant through Historic Preservation. Sammy Thomas is their new President. No needs from Committee.
