b. Big Sky Rail Funding - CAO Green

This is the Mayors project she has been pushing forward. Big Sky Passenger Rail Authority is starting to launch resolutions and budgets to help fight for rails in SW Montana. They are going to have people in place that will be fighting for certain regions. Terry Jennings is working on this for Deer Lodge and for our area trying to get a new rail through. They are putting together a budget and have asked Powell County for \$2,045.00. Mayor wanted the city to pay for half of that and the county pay the other half. Mayor is asking for your recommendation to forward this to Finance then Council for our share of \$1,024.00 to the study. Member Henderson motioned to approve the \$1,024.00 with a favorable recommendation to Finance and Council. Member Bohrer seconded the motion. Unanimous vote, the motion passed.
