b. Charter Government-Discussion

CAO Green, a traditional local government whether its county or city has specific rights at a state level that allows a city to do certain things. A city under a traditional government cannot do something that the state government doesn't specifically allow them. Whenever you pull up an MCA code it will say "A City" or "local municipality" is authorized to hire a police chief (example) or is authorized to create a growth policy. Because if its not mentioned in a local government we are not allowed to do it. What a charter government does is allows you do all those things that haven't been specifically allowed at the state level. Basically, if it isn't prohibited your allowed to do it at a state or local government level.

Member Bohrer asked what is the difference between a city and a county? Does the city have to be on board with this?

CAO Green, yes. There are two different things, and I would highly recommend no on consolidation for Deer Lodge and Powell County just because of the size of our county.

Member Bohrer I think a strong healthy relationship between the two is important, but I don't think consolidation is

Member Hathaway, if we were to become a charter, how would that effect our grants?

CAO Green, it shouldn't affect it. Member Bohrer stated it should open more doors.

Member Hathaway, what's the difference between a self-government charter and a chart?

CAO Green, it might be because of the different form of government. We have Council/Mayor Government it may be a Commission/Manager style, that may be the difference.

Member Hathaway, How would we notify the people of this?

CAO Green, you would have to put it on a ballot 2024 and vote to basically start the process and have it on the next ballot 2 years later to vote to adopt it.

Member Henderson, I would suggest holding a special session for the people.

CAO Green, to move this forward my suggestion would be is to get a very clear set of goals as to why you want to become a Charter Government.
