4. County Health Report......Ida Miller

Powell County Public Health continues to offer Child Safety Seat inspections. They also have some child safety seats available on a sliding scale fee basis.

Testing and contact tracing for Coronavirus continues in Powell County. In November, there were 63 positive cases in Powell County. Over the month of November, there were 5 hospitalizations and 3 deaths. There has been an average of 4 contacts per positive case identified. The majority of Covid-19 cases found in Powell County are the Delta variant. Vaccination for Covid-19 is available to all residents of Powell County who are 18 and over. Deer Lodge Medical Center is administering the vaccine free of charge call 846-2212 or 846-1722 or check the DLMC website at dlmed.org. for more information or to register to receive the vaccine. The vaccine is also available at Safeway in Deer Lodge. Booster doses for individuals who are 18 years and older are now available. Everyone ages 18 and older should get a booster shot either when they are 6 months after their initial Pfizer or Moderna series or 2 months after their initial J&J vaccine.

Butte-Silver Bow is providing Pfizer vaccination for the 5- to 11-year-olds. They currently have the vaccine for 12 to 18-year-old age groups and Butte-Silver Bow Public Health has information regarding scheduling.

Montana State Prison does not have any staff or offender's positive with Covid-19.

The Omicron variant of Covid-19 is occurring among younger people. First case in U.S. was reported 11/30/2021. Testing should identify this variant. We know how to prevent this variant from spreading throughout our community, by getting vaccinated, getting your booster, staying home if you are ill. Use handwashing, masks, and social distancing to keep our community members safe.

There have been 13 state-confirmed influenza cases in Montana. Deer Lodge Medical Center and Safeway have vaccines for influenza available. Influenza and Covid-19 have similar symptoms and can occur at the same time. Only a lab test can determine if you have influenza, Covid-19, or both.

HIGHLIGHTS

- > 2 calls for service in December
 - 1 confined space rescue. Person passed out in sub floor molasses holding tank. Has since made a full recovery.

Powell County Public Health

Powell County Public Health continues to offer Child Safety Seat inspections. They also have some child safety seats available on a sliding scale fee basis.

Testing and contact tracing for Coronavirus continues in Powell County. In December, there were 34 positive cases in Powell County. Over the month of December, there were 5 hospitalizations and 1 death. We are seeing more people testing, we had about 180 tested. The majority of Covid-19 cases found in Powell County are still the Delta variant, but the Omicron variant has been found here.

Vaccination for Covid-19 is available to all residents of Powell County who are 18 and over. Deer Lodge Medical Center is administering the vaccine free of charge call 846-2212 or 846-1722 or check the DLMC website at dlmed.org. for more information or to register to receive the vaccine. The vaccine is also available at Safeway in Deer Lodge. Booster doses for individuals who are 18 years and older are now available. Everyone ages 18 and older should get a booster shot either when they are 6 months after their initial Pfizer or Moderna series or 2 months after their initial J&J vaccine.

Butte-Silver Bow is providing Pfizer vaccination for the 5- to 11-year-olds. They currently have the vaccine for 12 to 18-year-old age groups and Butte-Silver Bow Public Health has information regarding scheduling.

Montana State Prison has had staff and offenders testing positive with Covid-19 during the month of December.

New guidelines for isolation and quarantine have been issued by the CDC and Montana DPPHS. For the general population, a positive case must isolate for the first 5 days and if able to wear a mask may return to normal activities while wearing a mask at all times for the second five days. If exposed, the quarantine period is recommended by Powell County Public Health but can not be required.

There have been 6 confirmed cases of influenza in Powell County. Deer Lodge Medical Center and Safeway have vaccines for influenza available. Influenza and Covid-19 have similar symptoms and can occur at the same time. Only a lab test can determine if you have influenza, Covid-19, or both.

Isolation – General Population Updates

- Isolation for COVID -19 cases has been shortened to 5 days, regardless of vaccination status.
 - An individual may be released from isolation after five days if they are asymptomatic, or their symptoms are resolving, and if they can continue to mask for 5 additional days to minimize the risk to others (days 6-10).
- Updates are based on studies showing that an individual is most infectious 1 -2 days before, and 2-3 days after, onset of symptoms

If you have a fever, continue to stay home until your fever resolves

Isolation - General Population

Isolation guidelines apply to everyone, regardless of vaccination status

If positive:

- Stay home for 5 days
- If no symptoms, or symptoms are resolving, you can leave your house after 5 days of isolation
- Continue to wear a mask around others for 5 additional days (this is day 6 through 10)

Isolation starts based on symptom onset or positive test date

- If sick, day 0 is symptom onset date
- If asymptomatic, day 0 is test positive date
- this part of the guidance has not changed

If you have a fever, continue to stay home until your fever resolves

Quarantine Part 1 - General Population

Boosted or recently completed primary vaccine series:

Vaccination Status

- · Boosted, OR
- Completed primary series of Pfizer or Moderna within last 6 months, OR
- Completed primary series of J&J within last 2 months

Quarantine Recommendation

- Wear a mask around others for 10 days
- · Test on day 5, if possible
- <u>If you develop symptoms, get a test and stay home</u>

Quarantine Part 2 - General Population

Unvaccinated or no recent primary vaccine series:

Vaccination Status

- · Unvaccinated, OR
- Completed primary series of Pfizer or Moderna over 6 months ago and are not boosted, OR
- Completed primary series of J&J over 2 months ago and are not boosted

Quarantine Recommendation

- Stay home for 5 days. After that continue to wear a mask around others for 5 additional days (days 6-10).
- If you can't quarantine you <u>must</u> wear a mask for 10 days
- · Test on day 5, if possible
- If you develop symptoms, get a test and stay home
